

AN ANNOUNCEMENT OF PRESS GLASS SA, DATED ON OCTOBER 16, 2020

REGARDING THE CORONAVIRUS (COVID-19)

Due to the current changes in the epidemiological situation in Europe, we would like to inform that all Press Glass SA production plants continue to operate in a stable way. Analyses of incoming orders indicate that that in the coming weeks our deliveries will be carried out on standard dates. Companies providing transport services also informed us about the continued full availability of the means of transport covering our needs.

Owing to solid relations with our suppliers, we have the necessary stocks of all components for the production of insulated glass units. We have also planned and confirmed the appropriate levels of raw material deliveries in the coming weeks. We are also now ready to provide temporary support to other companies in the event of a disruption to the availability of processed glass products.

We maintain sanitary procedures in line with the applicable legal requirements. In addition, we have introduced procedures to maximize the continuity of production and deliveries of our products in the coming months.

We have established a special model of work for our offices and production shifts. Where appropriate and possible, our employees work remotely or in rotation. We maintain precautionary measures at our facilities to minimize business travel and meetings. We have provided additional disinfectants and personal protective equipment. We have also introduced temperature measurement and a special work mode that prevents employees of individual shifts and individual teams from meeting in production plants. We have increased security zones in cloakrooms, canteens and other shared areas. We have created a special mode of movement of employees within plants and at individual positions. We also conduct an educational campaign "Stay healthy and safe at work". We encourage our employees to act responsibly at work, on their way to and from work and in their free time.

We monitor the situation on an ongoing basis and, if necessary, we will individually and without undue delay inform our contractors about important factors affecting the operation of our plants and planned deliveries.
